



# THE OKANA LAGOON

## RULES:

- Wristbands are required for entry.
- Guests with open wounds, diarrhea, or illness are prohibited from participating in/on pools & attractions.
- Guests must shower using warm water and soap before entering or re-entering attractions.
- Do not intentionally put water in mouth or swallow water.
- Guests who require diapers are required to wear swim diapers/rubber diaper covers. Do not change diapers on the pool deck or lounge chairs.
- Only U.S. Coast Guard approved life jackets are allowed. No tubes, rafts, or inflatable "floaties" are permitted. Life jackets are required for guests under 48" at all times.
- Children under the age of 14 must have a supervising companion at all times.
- Coolers, outside food and beverages, and glass of any kind is not permitted.
- Alcohol, tobacco products, and vaping products are prohibited.
- Our lifeguards are highly trained and qualified. Follow their instructions at all times.
- Diving, running, profanity, and horseplay are not permitted.
- Appropriate swim wear is required for all guests. Denim-shorts, swim wear with plastic or metal rivets that may damage slide surfaces, thong suits, men's "Speedos", and clothing made of see-through material when wet or dry are prohibited. We reserve the right to determine the appropriateness of swim wear.
- Attractions may have specific height, weight, and safety requirements. Refer to the safety sign posted at each attraction to make an informed decision as to whether the attraction is right for you.
- Cameras, cell phones, and video recording devices may not be used on any slide, attraction or in any changing area or restroom.
- Animals of any kind are not permitted in the waterpark, with the exception of service animals. Service animals must be leashed and under the owner's control. Service animals are not permitted in water attractions, wet decks, wading pools, or lazy rivers. Relief areas are located outside the facility for your service animal.
- In order to provide a safe and enjoyable experience for our guests, OKANA utilizes training exercises to improve our lifeguards' skills and vigilance. The exercises will occur during normal operating hours and may consist of the following: Submersible water mannequins, the use of video surveillance equipment, internal and external audits, active/inactive water rescues, or first aid scenarios.
- Unless authorized by law, no person shall knowingly possess, have under their person's control, convey or attempt to convey a deadly weapon or dangerous ordinance on these premises.
- *OKANA reserves the right to refuse admission or to remove from the property any person(s) for any reason without refund or compensation.*
